4. FIRST AID MEASURES

EYES:

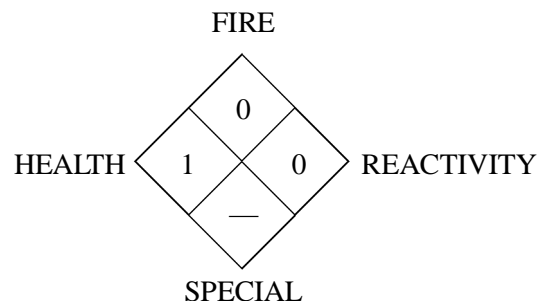
